FACILITATING SAFE FREE MOVEMENT FOR CITIZENS ACROSS EUROPE

Digital Green Certificate

The European Commission presented a proposal for a Digital Green Certificate to facilitate safe free movement of citizens across the EU. The certificate will be issued by Member States and will be available on a digital Green Certificate and will be valid in all EU member states.

WHAT IS THE DIGITAL GREEN CERTIFICATE?

- A Digital Green Certificate is a digital proof that:
 - You have been vaccinated against COVID-19;
 - You have received a negative test result; or
 - You have recovered from COVID-19.

I AM VACCINATED YESTERDAY. WILL I BE ABLE TO GO TO ANOTHER EU MEMBER STATE TODAY?

The Digital Green Certificate will be issued by each Member State, which is responsible for the vaccination of its citizens. The certificate will be valid in all EU member states.

DOES IT MATTER WHICH COVID-19 VACCINE I RECEIVED?

The Digital Green Certificate will be issued to anyone who has received a COVID-19 vaccine, regardless of the manufacturer. The certificate will be valid in all EU member states.

WHICH DATA DOES THE CERTIFICATE INCLUDE?

The certificate will include information such as the name of the持證人, the date of birth, the place of vaccination, the date of vaccination, the name of the vaccine, and the name of the manufacturer.

AM I PERSONAL DATA SAFE?

The certificates will only include minimum of personal data required for the verification of the certificate. The certificates will not contain any sensitive data such as gender, race, ethnicity, or sexual orientation.

HOW WILL LAST THE DIGITAL GREEN CERTIFICATE?

The Digital Green Certificate will be valid for 9 months from the date of issue. After this period, it will need to be renewed.

HOW WILL IT FREE MOVEMENT?

With the introduction of the Digital Green Certificate, citizens will be able to travel freely within the EU without having to provide proof of vaccination or negative test results at border controls.

HOW DOES THE DIGITAL GREEN CERTIFICATE WORK?

The Digital Green Certificate will be issued by each Member State, which is responsible for the vaccination of its citizens. The certificate will be valid in all EU member states.
